

### Avoid posting personal information to Medavie Blue Cross website

The Medavie Blue Cross Interim Federal Health Program - which provides temporary coverage of health-care benefits for specific groups of people in Canada - offers an online provider search to help patients find local physicians. Physicians have reported to the OMA that they have seen their personal information on this publicly available directory. The OMA recommends members only provide contact information for their place of practice - not a Medicine Professional Corporation - when adding a business address. The OMA has alerted Medavie Blue Cross to the issue. Physicians whose personal information appears on the directory can contact Medavie Blue Cross for assistance. #### Governance

#### **Tariff Report**

#### **1. PSA Implementation**

- The physician payment committee will be accepting year 3 proposals this fall and will have 1 year to complete the work.

- The formula for year 3 increases is complicated and based on utilization and the total PSB spend so estimates of the increase will not be calculated before next spring.

- Thank you to all members who responded to our survey that will inform the executive as we consider possible proposals that we might submit to the process.

# 2. Negotiations 2024

- The section made a written submission to the Negotiations Task Force (NTF) and met with them to discuss it.

- The NTF and the board are now working on their mandate ahead of negotiations which are expected to start in October.

# 3. Relativity

- The Relativity Advisory Committee has informed sections that it has decided against recommending the use of the controversial BEST (Benchmark Estimation of Service Time) methodology that involved conversion of one benchmark assessment or consult code per section to a time-based code.

- They are currently considering alternative approaches for estimating the hourly rate in the FAIR (Fee-Adjusted Income Relativity) model.

# 4. Unintended Consequences of Revisions to J069

- The PPC received our letter of concern and requested more information from us about the radiofrequency ablation services formerly provided using J069 and for evidence and practice guidelines supporting those services.

- Information was provided in July and we are awaiting a further response from the PPC regarding our members' concerns.
